Arlington County may elect up to 990 Delegates and an equal number of Alternates to the State Convention and 495 Delegates and an equal number of Alternates to the 8<sup>th</sup> District Convention.

Additionally, membership in the Arlington County Republican Committee is limited to 180 members, with each of 52 precincts assigned a specific number of members plus there are a limited number of At-Large members who are not assigned by precinct.

If fewer than the maximum number file for any specific position, all verified filers will be elected automatically.

**If a greater number should file for any specific position, a party canvass open to all Republican voters will be held, on Saturday, March 8, 2014, from 10 a.m. to 2 p.m., at ACRC HQ, and the candidates receiving the most votes will be elected.**

The time and place of the canvass may be changed as warranted; updated information will be available online and by phone.
